OVERVIEW

This document is a guide to installing ONESOURCE Corporate Tax and ONESOURCE Indirect Tax ("the software"). References to ONESOURCE Corporate Tax apply equally to ONESOURCE Indirect Tax.

We recommend that the installation of the software be performed by an IT professional.

INSTALLATION

The ONESOURCE installation wizard will guide you through the entire process of installing the software on your PC.

To install the software you will need to have sufficient permission to install software on your machine, in general this means the software must be installed by a user with Administrative rights.

The Installation Wizard

Insert the ONESOURCE CD into the CD drive of your machine.

The ONESOURCE splash screen should display automatically. If it does not, go to My Computer, double click on the CD drive to open it, and then double click setup.hta.

From this front page you can select which product you want to install. For reference, version numbers can be seen in the section at the right hand side.

On choosing an installation the ONESOURCE Installer will start a wizard that will guide you through the rest of the installation process.

You will be prompted to enter your company name and 25 character activation key, which may be found with the installation CD. Please enter your company name exactly as it appears on the CD and enter the activation key. To continue, click Next.

The next screen allows you to choose a local installation location. The default location is a folder in C:\Program Files\Thomson Reuters\ and will already be displayed. Although we recommend that you install the software to this location, you may change this location by clicking Change. Once the settings are correct, click Next to continue.

The following screen allows you to choose a location for the Working Folder. The working folder is a space where all your computations are stored. If you require a number of people to access your data it is recommended that you set this to a shared network location.

The next screen allows you to choose a location for the Shared Folder. The shared folder is a space that the software uses to store configuration information for all users of the software across your organisation. For this reason, it is recommended that you set this to a shared network location.

If you have already set a shared folder in a previous version of the software, this screen will not appear.

Finally a screen will appear indicating that the wizard is ready to begin the installation. Click Back to review or change any of the installation settings already entered, or click Install to start the installation.

The installation may take several minutes, when the process is complete, click Finish to exit the wizard.

The installation creates a shortcut to ONESOURCE Corporate Tax and ONESOURCE Administrator under the Start menu. You will be able to launch the software by selecting Start > All Programs > ONESOURCE > ONESOURCE Corporate Tax or Start > All Programs > ONESOURCE > ONESOURCE Indirect Tax.

Data Files

The software stores tax computations in a data file. The data files should be stored in a location that is backed up regularly.

There are two data files created per tax computation. Examples of these would be:

CompanyA10.abc	Latest version of a tax computation
CompanyA10.abk	Prior saved version of a tax computation

The size of each of these files is normally between 150-300Kb.

Where a return is filed electronically, additional XML files will be saved in the same folder as the tax computation, recording certain information such as the data submitted to HMRC and the responses. For further details please refer to the F1 Help and search for "online filing".

Terminal Services Installation

For details on installing the software in a Terminal Services environment, please see the 'ONESOURCE Corporate Tax and ONESOURCE Indirect Tax Notes for System Integrators' document, included on the CD.

SYSTEM REQUIREMENTS

We recommend the following minimum system specifications for running the software:

Hardware	The machine used to run the software should meet the Microsoft recommended specifications for the operating system installed.

.NET Framework	The .NET framework version 4.0 is required for ONESOURCE Corporate Tax and ONESOURCE Indirect Tax.

Application Architecture

ONESOURCE Corporate Tax and ONESOURCE Indirect Tax are developed using Microsoft Visual Studio 2012. This is the core Microsoft development environment and is a fully integrated development platform for Microsoft Windows.

The software has a component based design and makes use of the latest features in the Microsoft platform. The internal software architecture is periodically updated to take advantage of advances in processor and operating system design, e.g. recent releases have made more use of multi-threading to take advantage of the new Intel multi-core processors.

The ONESOURCE Corporate Tax and ONESOURCE Indirect Tax code is contained within the executable ABWIN32U.EXE, and a number of other Thomson Reuters software components. The software also uses Microsoft and other third party components.

SUPPORT

ONESOURCE Corporate Tax and ONESOURCE Indirect Tax are developed and owned by Thomson Reuters and as third party products, are neither supported nor endorsed by Microsoft.

The software is designed to work with Microsoft Windows. We undertake extensive platform testing on Microsoft Windows Vista, Windows 7 and Windows 8/8.1.

Windows XP

Microsoft stopped providing support for Windows XP on April 8th 2014. As a result, we can only support Windows XP on a best endeavours basis. Version 7.0 of ONESOURCE Corporate Tax and ONESOURCE Indirect Tax was the last version on which we performed extensive testing on Windows XP. Earlier versions of Windows

ONESOURCE Corporate Tax and ONESOURCE Indirect Tax are not supported on versions of Windows prior to Windows Vista. Windows 2000, Windows NT 4.0, Windows 98, Windows 98 Second Edition, and Windows Me (and their related components) were all transitioned to a non-supported status on or before July 13, 2010. After this date, Microsoft no longer provide any incident support options or security updates. The latest versions of Microsoft development tools no longer support building applications that are compatible with these older versions of Windows. As a result, the standard software installation will only operate on Windows XP2 SP2 and later operating systems. If you currently use the software on an unsupported operating system please contact us.
